## Interview With a Birthday



### What made you come to your first A.A. meeting?

Desperation. When I was 23 I was messing up bad and my parents knew about it. They convinced me to see a psychiatrist and I was diagnosed with schizoaffective disorder. After the diagnosis, they referred me to A.A. I went for six months and then went back out.

### What made you stay?

I knew I couldn't sustain this charade. I could see where my life was heading, and I didn't want to go there. Jails, institutions, death, and all that jazz. I felt lost and confused, and the drinking didn't help those feelings anymore.

### What was the most important thing you did in your first year?

I showed up to meetings daily. I do that today, too. Since I had that desperation, I actively listened in those meetings and took suggestions that changed my perspective.

### What was the most important thing you did in the last year?

I solidified my relationships with other A.A. members. I got closer to my higher power and gained a sense of clarity that I've never had before. Before, it was just me, isolated, couldn't rely on anyone else. Today, I rely on others in a spiritual sense. It's not brainwashing, just observable truths about human relationships.

### What's one thing you would like to stress to the newcomer?

Don't isolate, go to lots of meetings. Find a sponsor and keep in close contact with your fellow A.A. members. The absolute worst thing you can do is try it alone.

## The Third Step

I struggled with Step Three when I started. The 12x12 tells us Step Three requires action, but I couldn't get past reading the words *"made a decision"*, and understanding how exactly that involves action. I had made decisions thousands of times, but never do I follow through with all of them. So how was this decision going to be different?

I came into the program, broken, hopeless, and terrified, on the edge of insanity. It was easy admitting I was an alcoholic (Step One). I had known for years, if not decades. And I had no problem believing in a Higher Power (Step Two), because I was desperate for any sense of relief from this "obsession with the drink." I was excited for the journey I was taking and immediately started seeing benefits from quitting drinking. I was enlightened and intrigued by this "phenomenon of craving," and to find fellowship with others suffering the same fate and couldn't wait to learn more.

But just how exactly was making a decision to turn my will over to God supposed to work? If it involves action, what was it?

As I read further into Step Three in the 12x12, more things were revealed. The more I prayed, the more confidence I seemed to have that I was starting to see something change in my life and gave credit for this change to my Higher Power. I started having gratitude towards the things I take for granted. Although I couldn't see clearly what I was supposed to do, I was getting better at learning what not to do. When it came time to start making decisions on things, I was more decisive and less uncertain. My conscious contact with God was growing stronger. But I was still stumped trying to find what action I was supposed to take.

And then I got to p. 40: *"When he acquires willingness, he is the only one who can make the decision to exert himself."* It instantly made sense to me. That's how it's done. That's how this works. I must be the one to exert myself and be willing to do so. That's why everyone says you have to want it, because it's our will that drives everything we do.

Further down p. 40, I read, *"Our whole trouble had been the misuse of willpower."* How many opportunities had I missed, mistakes had I made, time had I squandered, all because I wasn't willing? Willing to practice; willing to give; willing to take; willing to leave; willing to stay. I had to agree that my will was in fact my hindrance.

The first step helped me diagnose my problem. The Second Step offers the solution. But the Third Step explains clearly that it is up to me to take the medicine. Only I can swallow this pill to get better. Someone else can't do it for me. If God's will is the medicine, I have to align my will with His. For me, this was the answer.

## The Third Tradition

I came to A.A. at the tender age of 19. I stayed when I was 24. I came in with outside issues and preconceived notions. I heard a thousand and one new ideas every meeting. I could relate, but I wasn't sure I was in the right place. I've always suffered from a case of terminal uniqueness.

I was resistant to belonging. In the words of Groucho Marx *"I have no desire to belong to a club that would accept me as its member."* I was 24 for God's sake! A lifetime membership to Alcoholics Anonymous was not exactly my senior superlative. Thankfully, I had been gifted desperation and thus, kept coming around.

An old-timer grabbed me after a meeting. I told him I wasn't quite sure if I belonged here or not. He asked me if I had a desire to stop drinking. I said that I did. He told me "Welcome to the club. I'll see you tomorrow." So, I came back the next day. I would like to say that was a burning bush moment and from then on, I committed myself whole-heartedly to sobriety and I haven't had a drop of alcohol since then. I would like to say that, but then I would be a liar. However, that conversation ignited the fire of desire, and I kept coming back until the day I stayed.

Millions of people walk into an A.A. meeting every day. If you think you have a problem with alcohol and don't know what to do, welcome. If you're a self-described alcoholic and know you're through drinking, welcome. If you're lost and confused and somebody told you you should check out A.A., welcome. I reach my hand out to you just like that old-timer did for me. As a consequence of the desire to stop drinking, we are able to tap into a fellowship and program that is much greater than the sum of its parts.

### Board of Directors Treasurer: Mike S.

I hope everyone received a copy of the 2024 Budget; it was approved and passed by the Board of Directors. Last year we had a \$30,000 deficit which was a combination of contributions going down and expenses going up, so we are trying to stem that tide. As you can see, we have looked at our contributions and came up with a conservative figure on what our income and expenses are going to be. Some expenses are what they are, rent is rent, salaries are salaries. I think we have done what we can to improve our expenditures. Currently we show a \$4,000 loss for this year as opposed to a \$30,000 loss last year. However, what we did not include in our income are the three fundraisers we have this year: Gratitude Ball, Men's Night Out and Founder's Day. Historically these events have made money. Last year they contributed \$6,000 to the budget. We did not include that in the budget so if that trend continues this year, we will have a positive figure. Judy, our Office Manager, is well on board with some of the lean trims to the budget that were necessary to make. Our mission here is to carry the message and if our doors are locked how are we going to do that? Finally, we did have a huge expense last year that we do not anticipate having this year which is the new updated Hybrid equipment.

### Co-Chair of Hotline / 12-Step Volunteers: Todd M. – Report given by Hotline Chair Saul for Todd M.

Hi, my name is Saul, I am doing the 12-Step Report for Todd. He said everything is going smoothly, we have 50-60 men's numbers, not sure about the women's numbers. Todd is working on getting more women to do outreach and is trying to get women's numbers up on the 12-Step List.



### **Accessibility and Meetings-to-Go Chair: Joan R.**

Hi, my name is Joan. I am an alcoholic and the chairperson of the Accessibilities Committee. Meetings to Go is our meeting service to bring AA meetings to members in nursing homes, group homes, and rehab hospitals. Remote Communities also fall under the responsibility of our committee. The General Service Office defines Remote Communities as anyone who has difficulty accessing AA meetings due to differences in geography, language, and culture. Our Spanish-speaking AA members in District 21 belong to what is called a linguistic remote district, and we are working hard to bring our English and Spanish-speaking committees and service groups closer together.

To this end, we are planning on holding a series of technology workshops for Spanish-speaking GSRs, Intergroup Reps, Committee Chairs, Liaisons, etc., so they can set up email accounts and learn how to use online meeting applications. C.P.C.'s activities during January 2024 are as follows:

- C.P.C. conducted a presentation to PACT Coalition (PACT = Prevention, Advocacy, Choices, Teamwork). I summarized the historical relationship A.A. has with Professionals from a variety of disciplines and I stressed the need to grow that relationship. I reviewed with them A.A.'s various resources and explained how they may be helpful. I updated them on the results of A.A.'s 2022 Membership Survey and how the impact from Professionals has declined during the previous eight years. I issued a Call to Action, to unite in the efforts to combat alcoholism. The outcome of the presentation was outreach to me by NAMI (National Alliance On Mental Illness) and, Mental Health Spectrum (a resource for psychological wellness). More to come!
- C.P.C. conducted another presentation to soldiers with the Nevada Army National Guard. It was a great success and the Guard asked us to be prepared to conduct another one here in the Vegas area in





the Spring and to conduct one in the Reno area in March! I've coordinated with our C.P.C. colleague, Terri M, in Tahoe/Truckee for this event! Terri finalized arrangements with the Guard's Prevention Coordinator up north! This is very exciting for A.A. and for the Nevada Army National Guard! More to come!

- C.P.C. in conjunction with District 17 reached out to the Nye Communities Coalition and asked to participate in their monthly meeting. We are warmly welcomed! We will attend our first meeting on Wednesday February 21, 2024. The goal is to provide visibility to the great resources A.A. has available. More to come!

- C.P.C. is also working with District 19 and will meet with members of the Ely community this summer.

- C.P.C. will attend District 1's monthly meeting in the next couple of months.

- C.P.C. is finalizing arrangements for the upcoming Round Table Forum: Obstacles to Sobriety!

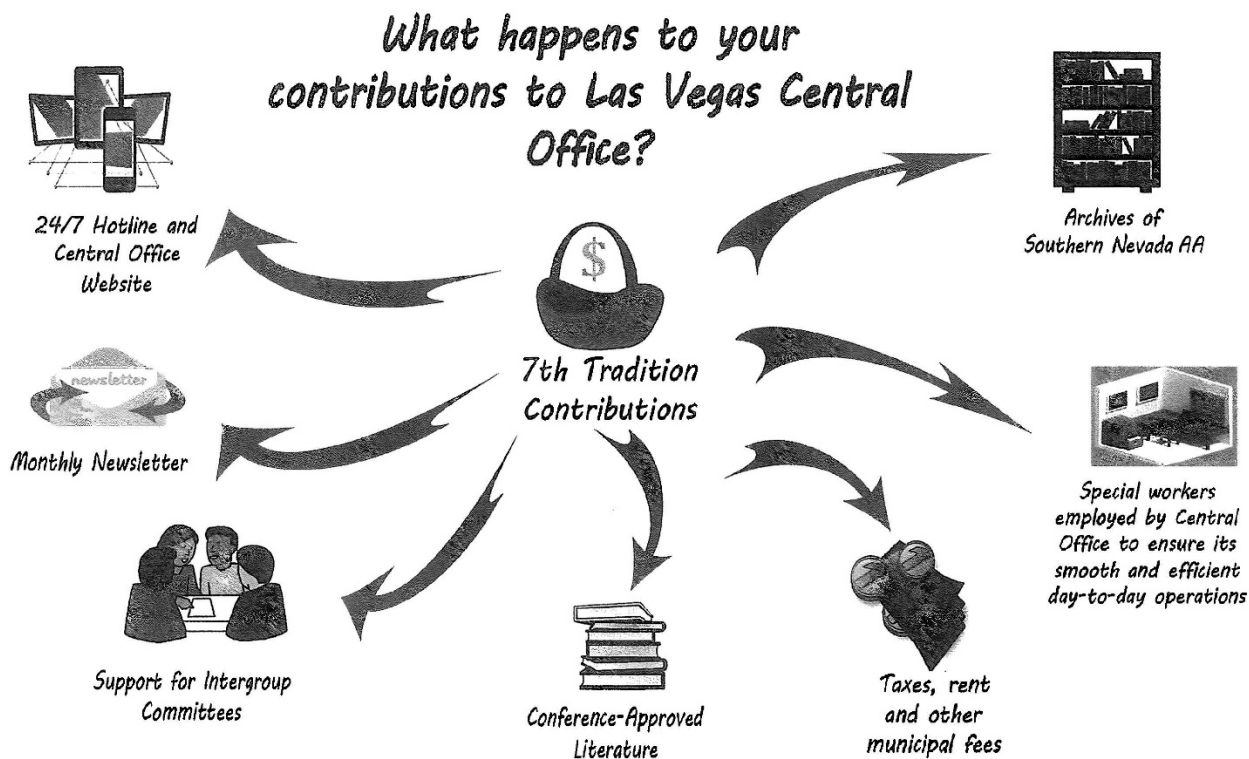
