Step Twelve

Step Twelve says, “Having had a spiritual awakening as the result of these steps, we tried to carry this message to alcoholics, and to practice these principles in all our affairs.”

Part 1: “Having had a spiritual awakening as the result of these steps...”

A spiritual awakening comes as a result of working the first eleven steps. This process isn’t something you should navigate alone; a sponsor can be an invaluable guide for helping you understand and apply the program of AA. Through this work, I’ve experienced a profound change in perspective, purpose, and connection in my daily life.

Part 2: “we tried to carry this message to alcoholics...”

Carrying the message first requires understanding what our individual message to others is. It isn’t limited to speaking directly with another alcoholic but is reflected in how we live each day. It’s in the small moments—our actions, attitudes, and willingness to be of service—that the message resonates most powerfully.

Part 3: “and to practice these principles in all our affairs.”

Living these principles demands commitment and action. It means applying honesty, humility, and service not just in recovery but in every aspect of our life.

My message is simple: I’ve had a spiritual awakening as the result of these steps, and have been gifted the three things I covet: a career, someone to share my life with and home ownership.

Ask yourself, “What do I want?” Whether it’s peace of mind, freedom from debt, or an end to chaos, these gifts come through practicing the principles of AA daily. In my 18 years of sobriety, I’ve seen countless lives transformed by thoroughly applying the steps as outlined in the Big Book. The promises of the program are real, but they require commitment and action from which you mustn’t waiver.



Tradition Twelve

“Anonymity is the spiritual foundation of all our traditions, ever reminding us to place principles before personalities.”

Long Form:

“And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice a genuine humility. This to the end that our great blessings may never spoil us; that we shall forever live in thankful contemplation of Him who presides over us all.”

Principles First – People Second

Why are we repeatedly asked in the Traditions to give up ourselves for the greater good? The answer is because any relationship we have that does not involve sacrifice is a relationship that likely will not endure. Each tradition straightens out a disastrous attitude we had about relationships. The twelfth tradition teaches us that a spirit of sacrifice (often times through anonymity) is vital to good relationships.

Giving up the expectation of rewards for doing good is difficult for most of us. It’s easy for us to give and then think, “Well, I’ll get a reward, even if I don’t get public recognition for what I did.” To remove that reward symbol from the back of our minds for whatever good we do is part of practicing anonymity. The next time you hear a speaker in A.A. whose personality is exciting from the platform, see if you can hear the principles behind their words? To which step, tradition, or concept can you relate their pitch? Setting ourselves aside and focusing on the principles of our program is a crucial component in the foundation we need for studying the Traditions and learning how to be in healthier relationships with our fellow A.A.’s and with those in the world around us.

Step-Tradition Parallel

The twelfth step poses the question, “What is a spiritual awakening?” I believe that the evidence of a spiritual awakening is found in a person who practices the twelfth tradition in all their affairs. Such a person sacrifices self in order to practice principles. Their motive in practicing all of the traditions is anonymity: they sacrifice to help others.

The twelfth tradition completes the twelfth step in the following way: I become spiritually awake when I carry the message by anonymously practicing sober principles.

Intergroup Meeting Minutes

December 9, 2024

7th Tradition: \$74.00

New reps: 1

Reports

Central Office Manager: Mike S. (temporary)

The office is continuing to run smoothly during our manager vacancy. Our part-time staff have been gracious to work the additional hours to maintain the office's 44 business hours per week.

- 1) We have one hotline vacancy on Monday afternoons, 12 noon to 4 pm. Contact the office if you would like to be of service.
- 2) We had purchased and received our initial order of 100 copies of the first edition, first printing of the "Plain Language Big Book". After receipt of the books, GSO had emailed a notification of five minor corrections to the book which will be rectified on the second printing. Every purchaser gets a page of the corrections with the book. The book is selling briskly. We have about 20 copies left from this first order. We have an order placed for 200 copies of the second printing. We are selling the book for its suggested price of \$11.
- 3) With Intergroup's approval, our new office manager, Eileen P., will begin work for us on Tuesday, December 17, 2024.

Board of Directors Treasurer: Mike S.

- 1) We are continuing to monitor our budget. Our group contributions are still declining but are at slightly more than 100% of our conservative budgeted expectations. Our individual contributions are not faring as well. Currently, we have received contributions at 63% of our conservative expectations. Our meeting room use is doing well above budgeted expectations, currently at 130%.
- 2) On the expense side, we're doing our best to stick with the budget. On many categories, we are under budget, on some, we are slightly over budget, simply because the costs for certain items have increased.
- 3) Our forecast for the year was to be in the red, \$4,045. To date, I would tell you that we are in the red at \$6,245 on the financials for the year, excluding the following information.



4) That information is as follows: we received the ERC monies that were applied for in 2023, a total of \$41,081. You'll also see an expense of \$3,397 consulting fee, which is the final payment for the CPA who performed the ERC calculations on the application. That expense was not in our proposed budget.

So, our financials will show that we are in the black at \$31,435.

5) We've temporarily moved \$30,000 of that money into our prudent reserves. It will be moved again into a 3-month CD shortly, that will fit into the "laddering" effect with our current CD's.

6) Lastly, we've been notified by an attorney that we will be receiving a \$10,000 contribution that was bequeathed to us by a grateful member of AA.

12 Step List: Todd M.- No report

Accessibility and Meetings to Go Chair: Diana M. for Joan R.

Hello, my name is Joan R., and I am the outgoing Chair of the Accessibilities Committee for Southern Area 42 and Las Vegas Intergroup. Over the past two years, Accessibilities has gone through many changes. When I first started this commitment, the committee had been inactive for a number of years, and generally suffered from ignorance about our mission and our purpose.

One of the first changes I implemented was to separate us from the PI/CPC/Accessibilities group committee meeting. Although I recognize the ideal of sharing resources between committees, the general AA membership grew confused as to what made our committee different from the other two.

We are a committee of alcoholics serving other alcoholic members of AA, while the other two committees reach out to non-members. Our goal is to make our meetings, literature, and service accessible to all alcoholics whether they have a disability, speak a language other than English, or live hundreds of miles from our Intergroup office.

Early on in my commitment, we pushed to have Intergroup hold hybrid meetings. Although there was some pushback at first, I think everyone has adjusted nicely and it has allowed more people to attend Intergroup, particularly ones who live in remote areas or who are unable to drive at night.

Meetings To Go/Reuniones Para Llevar – a sub-committee of Accessibilities - had also gone dormant during lockdown, and we revived this important service to help bring meetings and contact to alcoholics in hospitals, nursing homes, group homes and other care facilities. We learned a lot and made some mistakes along the way, but I have heard from many people how much this committee meant to them



either as a volunteer or as a recipient.

Starting in my second year, Diana M. joined me as co-chair and we worked really hard on various projects. We hosted a Technology workshop last spring for our Spanish-speaking members in District 21 and we have slides and support so that others may hold similar workshops in their districts. We also held a workshop for Seniors In Service featuring a panel of eight members who have served AA in various service positions including General Manager of GSO, Alcoholic Trustee, Delegate, Hospital and Institutions panelist, and a dedicated sponsor of many sober women.

Our final project for this panel is our new service piece, the AA Member Resource Finder, which is a pamphlet of QR codes for various AA intergroups and service areas to help alcoholics find the resources they need to find sober support. Resources include websites for the AA Hispanic Central Office in Las Vegas, Deaf AA, LGBTQ AA, Native American AA, and other resources including the AA Online Intergroup website which provides meeting listings for hundreds of groups around the world that meet in various languages and serve different populations.

Thank you to those of you who remain curious enough to learn about what we do, and to learn that Accessibilities is much more than “just wheelchairs”, which, by the way, we donated to Central Office earlier this year. This commitment has been stimulating and challenging and I look forward to supporting Diana as Co-Chair as she expands on our previous work.

Board of Directors Chair: David G.

Good evening my name is David, and I am an alcoholic.

The Board met a couple weeks of ago, whereby we narrowed down our selection of candidates for Central office manager to two candidates. Upon presenting them to the Board, the Board decided and Eileen P. was selected as our new Central Office Manager. Eileen will be starting on December 17. We are excited for her and look forward to her success.

I also attended the Las Vegas Round Up and set up the literature table for Central Office. I had a great time and sold about 8 to 10 items. I enjoyed being there and I had the opportunity to meet with a lot of



friends in the fellowship.

The Board of Directors is also looking to fill one Board position.

Cooperation with the Professional Community /CPC Chair: Chris H. Hi everyone! I'm Chris H, an alcoholic and the outgoing chair of the Cooperation With The Professional Community committee (C.P.C.) for Southern Area 42.

As you know, the COVID lockdown had a devastating impact on A.A. and C.P.C.'s effectiveness waned. But, over the last two years, by actively participating in community organizations and coalitions in the southern area, namely PACT Coalition and L.I.M.A. in Clark County and Nye Communities Coalition, serving Nye, Lincoln and Esmeralda Counties. Through our participation, we re-established awareness outside of the fellowship, awareness of A.A.'s meetings, events and resources. In fact, because of this simple effort, we not only fully recovered from COVID, but we made great strides in advancing our mission.

In 2023, C.P.C. established our Forum For Sober Communities – a workshop wherein members of our fellowship and Professionals outside A.A. candidly discuss alcoholism, obstacles to sobriety and how we can cooperatively challenge the obstacles and hopefully overcome them. As a result of that workshop, a new relationship with the Nevada Army National Guard evolved. Since then, we conducted four presentations to more than 500 soldiers here in the southern area and one presentation in the northern area. This is probably the greatest accomplishment of our committee in these two years.

The 2023 workshop was so successful, we conducted another in 2024. We had speakers from A.A.'s little-known committees and groups, namely: Accessibilities, Grapevine, and Young People in A.A. This part of the workshop brought visibility to A.A.'s resources that few if any Professionals were aware of – resources that they can access and hopefully help them in their dealings with active alcoholics.

Outside of our fellowship, we had speakers who discussed how their organizations cooperate with A.A. and why such cooperation is vital to combating alcoholics. These speakers represented Al-Anon; the Courts and law enforcement; the military; and treatment, two of whom addressed the challenges of recovery in remote and frontier communities in Nevada.

We had about 60 attendees, half participating in person and half participating remotely via Zoom – those who participated remotely were from all over the U.S., Canada and as far away as South Africa.

This workshop was a great success!



Our cooperative relationship with the Nye Communities Coalition is beginning to flourish. In October 2024, we were asked to staff an informational table at a Remote Area Medical pop-up in Pahrump. C.P.C. and District 17 attended. Over a two-day period, more than 300 Nye County residents and nearly 100 medical (and Corrections) professionals passed by our table – many of whom stopped to talk to us. Although much of our literature was taken, the most popular was the Spanish literature. This prompted District 17 to initiate efforts to re-establish A.A. meetings for the Hispanic community in the Pahrump area. One other outcome of attending this event stemmed from a discussion with the manager of Pahrump’s Senior Living facility. We discussed A.A.’s position on the elderly in sobriety and the resources A.A. has for seniors who may have challenges such as mobility. We’ve been invited to make a presentation to the management staff of the facility and potentially one to the residents! Another great success!

C.P.C.’s last event of 2024 was the Welcome The Newcomer Open House. We hosted a meet & greet, followed by a potluck lunch and ended with a speaker meeting. We reached out to Las Vegas treatment/recovery centers, as well as sober living homes, to bring awareness of the event to those who don’t regularly attend A.A. meetings. Forty people attended, half of whom were new to sobriety and a dozen with less than 1 year. Our speaker was Shaun F – his story focused on the joys of being sober and inspired great sharing by everyone, including those only a few days sober! We were urged by all who attended to do it again next year!

At our October C.P.C. committee meeting, we did a recap of the year and unanimously agreed that the committee should continue to: cooperate with the coalitions, conduct presentations with the Army National Guard, and host the Forum For Sober Communities workshop and the Welcome The Newcomer Open House. We hope that the incoming committee chair will bring ideas to strengthen what we do well and open doors for new ways of cooperating and spreading the word of what A.A. does and does not do.

From a personal perspective, I wish we had been able to make greater inroads with the remote and frontier communities and start to work within the Hispanic communities. I’m glad we started to do so in District 17 but Districts 19 and 21 have opportunities as well and I hope that my successor has a desire to partner with those DCMs.

This service commitment truly changed my life. It opened my eyes to the true value of A.A. and ALL of its resources. It gave me a new understanding of what it means to “extend the hand of A.A.” to those who suffer outside of the rooms. I gained immense knowledge of the respect that Professionals, such as Yale, Harvard and Stanford Universities, the National Institute of Health and the American Psychiatric Institute have for A.A. And most importantly, for my own personal growth, I have experienced true humility. Please try a service commitment with the C.P.C. committee – I promise that it will rocket you

Outreach Committee / Unity Chair: John L.

I am the chair of the ad hoc committee for the Intergroup Guidelines. Outreach Committee is in the process of being rebuilt. I have provided a form to Central Office whereby AA members can fill this out when there are issues with groups that need to be followed up on. If we approve the Intergroup Guidelines the Outreach committee will then be called the Group Relations Committee and will be bundled together officially. Outreach is about getting out to the groups, and we really need to do that. We have a little over 20 Intergroup reps here tonight, but we have over 300 AA groups in Las Vegas. If you know of any groups that you attend that do not have an Intergroup rep you might want to let them know that Intergroup really could use some support. More Intergroup reps mean we have a deeper voice for the collective conscience of AA. More reps mean more connectivity and creativity comes out of that and we can better serve the suffering alcoholic.

Regarding the Guidelines, I re-wrote them from the ones I had from 2014, but I did not touch the committee descriptions. I had asked for committee chairs to send me any changes they wanted, and I only received one. All Intergroup reps should have a copy of the draft Guidelines received last month.



Let us know if you do not have that. These Guidelines will be presented to the Intergroup and will be approved or not in January. This is how we will be operating as a body.

We will have 3 readings of the new Guidelines. I won't read it tonight; it is 11 pages. I did receive a new description from Accessibilities and I will read that tonight. It will be considered the 1st reading.

We might want to consider in a future action combining the by-laws and guidelines together in one document where there is an electronic version. That is my recommendation.

The next step is: I will accept all changes to the Guidelines from committee chairs, I will consider all requests and recommendations coming from the Intergroup body have for me. I would like to have those
by December 26th.

At our next Intergroup meeting we will have the final reading of these Guidelines. Any clarifications, questions or changes will need to be done at that time. Once that happens, we will vote whether to adopt the Guidelines.

Starting next month, Bryan F. will be the new Outreach chair. He will need a lot of help. If you are an Intergroup rep or committee chair you can help him by visiting some meetings and bringing up the idea that the group can use an Intergroup rep so that they have a voice to AA and the local community.
